Ivan Chaidez, Assistant Superintendent, Education Services, reported on the 2016-2017 Single Plans for Student Achievement (SPSA) for Lu Sutton, Lynwood, Loma Verde, Olive, Pleasant Valley, Rancho, and San Ramon Elementary Schools. Schools operating programs funded through the Consolidated Application must submit a formal Single Plan for Student Achievement (SPSA) annually to the Board of Trustees for approval. The previous plans were written for two years, 2014-2016, and have now been updated based on new data for the 2016-2017 school year.

All schools are continuing to focus on making academic gains for all students with specific focus on English Learners, socioeconomically disadvantaged and foster youths.

Each principal in collaboration with their Site Council, ELAC, Staff and PTA have developed strategies and action steps to support our district-wide goals and priorities. Tehniat Cheema, Loma Verde Principal, Bonnie Barron, Lu Sutton Principal, Andy Cline, Lynwood Principal, Elizabeth Olinyk, Olive Principal, Dana Sadan, Pleasant Valley Principal, Angela Kriesler, Rancho Principal, and Amanda Langford, San Ramon Principal, shared a slide presentation about their SPSAs. The SPSAs, along with the slide presentations, will be posted on the NUSD website after Board approval.

The voter pamphlet mentioned the importance of supporting the health, education and safety of underserved children, and approximately \$12 million in annual local funding will expand quality preschool education, provide healthcare, expand afterschool and summer learning programs, promote reading, writing and math achievement, and provide affordable childcare for infants, toddlers and young children. The funding would come from a one-fourth percent sales tax for nine (9) years incumbent upon a two-thirds voter approval.


